Limited Liability Company

- Proof of EIN Letter from IRS or Current Tax Return
- SSN or EIN Single Member LLC
- Certificate of Filing/Formation
- Articles of Organization or Operating Agreement, if any
- Resolution
- Assumed Name Certificate (if applicable)
- Beneficial Ownership Name of individual person(s) owning 25% or greater of the entity
- Beneficial Ownership Name of individual person with significant responsibility of the entity

Limited Partnership

- Proof of EIN Letter from IRS or Current Tax Return
- Partnership Agreement
- Certificate of Filing/Partnership
- Resolution
- Assumed Name Certificate (if applicable)
- Beneficial Ownership Name of individual person(s) owning 25% or greater of the entity
- Beneficial Ownership Name of individual person with significant responsibility of the entity

Limited Liability Partnership

- Proof of EIN Letter from IRS or Current Tax Return
- Certificate of Filing/Partnership
- Partnership Agreement, if available
- Resolution
- Assumed Name Certificate (if applicable)
- Beneficial Ownership Name of individual person(s) owning 25% or greater of the entity
- Beneficial Ownership Name of individual person with significant responsibility of the entity

Corporation - For Profit/Non-Profit

- Proof of EIN Letter from IRS or Current Tax Return
- Certificate of Filing/Formation
- Board Meeting Minutes The customer should provide an excerpt from the minutes of the last board meeting where officers were elected—specifically the Secretary of the corporation since this person must sign the resolution.
- IRS 501(c) Tax Letter (non-profit only) (NOW Checking)
- Resolution
- Assumed Name Certificate (if applicable)
- Beneficial Ownership Name of individual person(s) owning 25% or greater of the entity (for profit only)
- Beneficial Ownership Name of individual person with significant responsibility of the entity

General Partnership

- Proof of EIN Letter from IRS or Current Tax Return
- Assumed Name Certificate with more than one owner listed
- Certificate of Filing/Formation, if no Assumed Name Certificate
- Partnership Agreement, if available
- Resolution
- Beneficial Ownership Name of individual person(s) owning 25% or greater of the entity
- Beneficial Ownership Name of individual person with significant responsibility of the entity



Required Account Documentation

Sole Proprietorship

- Proof of EIN or Social Security Number
- Assumed Name Certificate, with one owner listed, filed in the county where business is done
- Resolution

Unincorporated Association/Organization/Club

- Proof of EIN Letter from IRS or Current Tax Return
- Charter, By-laws, or Letter of Purpose
- Meeting Minutes Provided by customer authorizing account opening and signatories.
- Resolution

Agency Accounts

- Proof of EIN or Social Security Number
- Agency Agreement, provided by customer
- Resolution
- Beneficial Ownership may be required depending on entity

IOLTA (Interest on Lawyer's Trust Accounts)

- EIN of Texas Access to Justice Foundation
- Documents on proper entity (LLP, Inc, Partnership, etc.)
- Resolution
- Beneficial Ownership may be required depending on entity

- Commercial NOW Checking

Benefit or Tragedy

- Proof of EIN Letter from IRS or Current Tax Return
- Valid identification on Authorized Signers, CIP
- Charter, Bylaws (if available)
- Meeting Minutes (if available)
- Resolution

Campaign

- Proof of EIN Letter from IRS or Current Tax Return
 - o Commercial Checking
 - Resolution
 - o May have a filing document
- SSN
- o Regular Checking
- Uniform Single-Party/Multi-Party Account Selection Form Notice

Estate

- Proof of EIN Letter from IRS or Current Tax Return
- Death Certificate, original or copy
- Letters of Testamentary or Letters of Administration
 - o Either document must state who the Executor/Administrator is of the Estate.
